

RESOLUTION NO. 307

A RESOLUTION EXTENDING ACCEPTANCE OF  
NEGOTIATED EXCHANGE OF PROPERTY TAX REVENUES

SUNNYSLOPE COUNTY WATER DISTRICT

RESOLVED, by the Board of Directors of the Sunnyslope County Water District, San Benito County, California, that

WHEREAS, pursuant to Section 99 of the Revenue and Taxation Code of the State of California which requires that in case of a jurisdictional change in the boundaries of governmental bodies, such as this District, the District and the County must approve, by resolution, any negotiated exchange of property tax revenues;

WHEREAS, the County of San Benito and District have, through their authorized representatives, met and considered potential exchange of property taxes and pursuant to Resolution No. 81-33, adopted by the Board of Supervisors on March 2, 1981, and Resolution No. 280 adopted by the Board of Directors of the Sunnyslope County Water District on April 9, 1981, the parties agreed to negotiate an exchange of property tax revenues;

WHEREAS, on June 21, 1982, the Board of Supervisors adopted this Resolution No. 82-48 which extended the effect of said Resolution No. 81-33 for the period commencing January 1, 1982, and continuing through June 30, 1983;

NOW, THEREFORE, IT IS HEREBY FOUND, DETERMINED and ORDERED that this Resolution shall be, and it does hereby, constitute District's agreement to accept an extension of the negotiated exchange of property tax revenues whereby no taxes will be allocated to District in any jurisdictional changes from January 1, 1982, for the period effectively approved in said negotiations and hereby ending June 30, 1983, at which time District and County shall again review the effect hereof and decide whether the determinations made herein should continue or whether negotiations should be reopened on property tax revenues.





AREAS ANNEXED TO THE SUNNYSLOPE COUNTY WATER DISTRICT


BE IT RESOLVED by the Board of Supervisors of San Benito
