## A RESOLUTION PROVIDING FOR 1964 GENERAL WATER DISTRICT ELECTION

RESOLVED, by the Board of Directors of the <u>Sunnyslope</u> County Water District, County of <u>San Benito</u>, California, that

WHEREAS, a General Water District Election will be held in said District on the 24th day of March, 1964, the same being the fourth Tuesday in the month of March of said year, for the election of two (2) Directors of said District.

NOW, THEREFORE, IT IS HEREBY ORDERED as follows, to wit:

- 1. That said General Water District Election shall be held as provided by law in said District on Tuesday, the 24th day of March, 1964.
- 2. Blank certificates of nomination for use at said election shall be furnished by the District, and if the forms now on hand prove insufficient in number, the Secretary of said District will procure such additional certificates as may be reasonably required.
- 3. There shall be one precinct for said election, which precinct shall embrace the whole of said <u>Sunnyslope</u> County Water District, said precinct shall be designated "<u>Sunnyslope</u> County Water District Precinct No. 1".
- 4. The boundaries of said <u>Sunnyslope</u> County Water District Precinct No. 1 shall include all of such State and County Precincts as lie within said water district, all according to and as last established by the Board of Supervisors of the County of <u>San Benito</u> for the conducting of general elections in said County insofar as they fall wholly or partially within the <u>Sunnyslope</u> County Water District. Said consolidated precinct shall also include any other territory situated within the boundaries of said <u>Sunnyslope</u> County Water District, but which shall not include any territory within said precinct as established by said Board of Supervisors which is without said District. Said precincts, as so fixed by said Board of Supervisors, are hereby consolidated for the purpose of said election

hereby called into one precinct to be designated as above stated.

5. The voting place for the conduct of such General Water District Election within said <u>Sunnyslope</u> County Water District Precinct No. 1, and the respective election officers appointed therefor, shall be as hereinafter set forth, to wit:

- 6. The polls for said election shall be opened at 7:00 o'clock in the morning of the day of said election and shall close at 7:00 o'clock in the evening of said day, except as otherwise provided by law.
- 7. Ballots shall be provided in the form and in the number provided by law. The names of the candidates shall be arranged in alphabetical order. A one-half inch square shall be provided at the right of the names of each candidate wherein to mark the cross. A one-half inch space shall be left below the printed names of the candidates for each office, equal in number to the number to be voted for, wherein the voter may write the name of any person or persons for whom he may wish to vote. Preceding the list of candidates for Directors shall be the following notice:

"For Directors Vote for two (2)".

8. Notice and proclamation of said election shall be given as provided by law by publication of same once a week for at least two weeks in \_\_\_\_\_\_ Evening Free Lance \_\_\_\_\_\_, \_\_\_\_ Hollister, Cali\_\_\_\_\_\_ fornia \_\_\_\_, a newspaper of general circulation published in the County, there being no newspaper of general circulation published in the District.

- 9. Sample ballots shall be printed at the expense of said District and made available for applicants. Such ballots shall also be mailed, one to each voter entitled to vote at such election, so that all of said sample ballots shall have been mailed at least three (3) whole days before said election.
- 10. The Secretary of this Board is hereby authorized and directed to procure and provide the supplies and records that may be necessary to properly and lawfully conduct said General Water District Election, and to take such other actions and steps as may be necessary and requisite for the holding of said election.
- 11. This Board of Directors shall meet as a canvassing Board and duly canvass the returns of said election, on Monday, the 30th day of March, 1964.
- 12. A copy of this resolution shall be forwarded to the Clerk of the Board of Supervisors, County of San Benito, California.

  The Board of Directors of this District request that said Board of Supervisors in its resolution calling the 1964 General Water District Election for this District, designate the consolidated precinct, polling place, and election officers herein specified, and that the notice and proclamation of election be published in Evening Free Lance,

  Hollister, California, as designated in this resolution.
