RESOLUTION NO. 190

A RESOLUTION MAKING A NEGATIVE DETERMINATION ON ENVIRONMENTAL IMPACT, DETERMINING CATEGORICAL EXEMPTION AND PROVIDING FOR NOTICE THEREOF

WATER MAIN TO RIDGEMARK RESERVOIR SUNNYSLOPE COUNTY WATER DISTRICT

RESOLVED, by the Board of Directors of the Sunnyslope County Water District, San Benito County, California, that

WHEREAS, a Preliminary Environmental Assessment has been prepared by the District Engineer and filed with the District Secretary, which recommends that the project is the connection of an existing pump at Well No. 5 to the existing water distribution system and that it be determined to be categorically exempt pursuant to Sections 3.5.A., Class I and 3.5.C., Class III of the District's Local Environmental Guidelines and Sections 15101 and 15103 of the State Guidelines as a minor modification of existing facilities consisting of construction of small structures which will have substantially the same purpose and capacity as existing facilities;

WHEREAS, the project concerning which this determination is made is described as follows:

The furnishing of all labor, materials and equipment required to connect the pump at Well No. 5 to the existing water distribution system on Ray's Circle near Donald Drive in Ridgemark Estates near Hollister, California in accordance with the plans and specifications.

WHEREAS, this Board has heard and considered the evidence and facts presented relating to the nature of the proposed project;

NOW, THEREFORE, IT IS HEREBY FOUND, DECLARED and ORDERED, as follows:

1. That, for the following reasons, it is hereby found that said Project is categorically exempt and will not have a significant effect upon the environment:

- (a) Water main and appurtenances replace and make minor modifications in existing structures. Replacement of water main and appurtenances from the existing well to existing water main is the best way to assure a satisfactory public water supply.
- (b) New water main and appurtenances will have substantially the same purpose and capacity as facilities being replaced.
- 2. That the Secretary be, and he is hereby, authorized and instructed to file certified copies of this Resolution and a Notice of Exemption with a copy of the Preliminary Environmental Assessment attached at the District office to be available for public inspection and copying and in the office of the County Clerk of San Benito County.
