A RESOLUTION DETERMINING THAT THAT PORTION OF SUNNYSLOPE COUNTY WATER DISTRICT TO BE KNOWN AS IMPROVEMENT DISTRICT NO. 2 OF SUNNYSLOPE COUNTY WATER DISTRICT WILL BE BENE-FITED BY THE PROPOSED PROJECTS AND BY THE METHODS OF FINANCING THE PROJECTS

SUNNYSLOPE COUNTY WATER DISTRICT IMPROVEMENT DISTRICT NO. 2

RESOLVED, by the Board of Directors of Sunnyslope County Water District, County of San Benito, State of California, as follows:

WHEREAS, on May 11, 1972, this Board adopted its Resolution No. 114, "A Resolution Describing a Portion of Sunnyslope County Water District Proposed to be Established as Improvement District No. 2, Declaring Intention to Undertake Projects within Said Improvement District No. 2, Declaring Proposed Methods of Financing the Projects, and Providing for Notice and Hearing Thereon", which resolution, together with notice of said proposed hearing, signed by the Secretary of this District, was posted in five conspicuous places within proposed Improvement District No. 2 at least ten (10) days prior to the date set for said hearing, and was published in a newspaper printed and published in the County of San Benito and circulated within proposed Improvement District No. 2 for two weeks, with said publication being completed at least seven (7) days prior to said hearing, as appears from affidavits on file with the Secretary of this District;

WHEREAS, additional notice of said proposed hearing was given by said Secretary by mailing a form of notice indicating the time and place of said hearing to each person to whom real property in said Improvement District No. 2 of Sunnyslope County Water District is assessed as shown on the last equalized assessment roll of the County of San Benito, and to every owner of property assessed by the State under Section 14 of Article XIII of the State Constitution at the address thereof shown on the last Board of Equalization roll transmitted to the County Auditor and to each person, whether owner in fee or having a lien upon or legal or equitable interest in any real property within the said proposed Improvement District No. 2, whose name and address and a description of the real property in which he

- 4. No improvement district tax shall be levied for the financing of said projects or either of them within Improvement District

 No. 2 of Sunnyslope County Water District. Taxes shall be levied,
 however, for District debt service and general purposes in said

 Improvement District to pay the costs of administration, maintenance
 and operation of the water and sewer systems and facilities in
 or for said Improvement District.
- 5. The District Secretary shall make, or cause to be made, such filings as are required in the office of the State Board of Equalization and in the office of the County Assessor pursuant to Chapter 8, Part 1, Division 2, Title 5, of the Government Code of the State of California (commencing at Section 54900 of said Code).
- 6. This resolution shall become effective thirty (30) days after its adoption.
