A RESOLUTION REQUESTING TAX LEVY FOR THE FISCAL YEAR 1973-1974

SUNNYSLOPE COUNTY WATER DISTRICT AND IMPROVEMENT DISTRICTS NO. 1 AND NO. 2 OF SAID DISTRICT

RESOLVED, by the Board of Directors of the Sunnyslope County Water District, San Benito County, California, that the minimum amount of money required by said District during the fiscal year ending June 30, 1974, for the purpose of paying the operating expenses of said District in excess of anticipated revenues, including especially the amount required for the payment of the principal of and interest on the bonded indebtedness of said District, which was incurred for the benefit of the entire District, as it comes due, will be in the sum of \$1,500.00, and that said Board of Directors does hereby estimate that said last mentioned sum is the minimum amount of money required by said District for such purposes during said ensuing fiscal year.

RESOLVED, that the minimum amount of money required by
Improvement District No. 1 of the Sunnyslope County Water District
during the fiscal year ending June 30, 1974, for the purpose of
paying its proportion of the operating expenses of said Improvement District in excess of anticipated revenues, including
especially the amount required for the payment of the principal
of and interest on the bonded indebtedness of said Improvement
District No. 1, which was incurred for the benefit of said
Improvement District No. 1, as it comes due, will be in the sum
of \$6,750.00, and that said Board of Directors does hereby
estimate that said last mentioned sum is the minimum amount of
money required by said Improvement District No. 1 for such
purposes during said ensuing fiscal year.

RESOLVED, that the minimum amount of money required by Improvement District No. 2 of the Sunnyslope County Water District during the fiscal year ending June 30, 1974, for the purpose of paying its proportion of the operating expenses of said Improvement District in excess of anticipated revenues, including especially the amount required for the payment of the principal of and interest on the bonded indebtedness of said Improvement District No. 2, which was incurred for the benefit of said Improvement District No. 2, as it comes due, will be in the sum of \$ none ___, and that said Board of Directors does hereby estimate that said last mentioned sum is the minimum amount of money required by said Improvement District No. 2 for such purposes during said ensuing fiscal year.

RESOLVED FURTHER, that said Board of Directors respectfully requests the Honorable Board of Supervisors of the County of San Benito, at the time when said Board fixes the taxes for County purposes, to include in the tax levy and collect a tax sufficient to raise said sum of \$1,500.00 during the said fiscal year, such tax to be known as the "Sunnyslope County Water District Bond and General Tax"; and further, said Board does hereby respectfully request the Auditor of said County to recommend such amount in the rates to be extended upon the tax roll of said County for said fiscal year on all property within said District.

RESOLVED FURTHER, that said Board of Directors respectfully requests the Honorable Board of Supervisors of the County of San Benito, at the time when said Board fixes the taxes for County purposes, to include in the tax levy and collect a tax, within Improvement District No. 1 of said District, sufficient to raise said sum of \$6,750.00 during the said fiscal year, such

tax to be known as the "Sunnyslope County Water District Improvement District No. 1 Bond and General Tax"; and further, said Board does hereby respectfully request the Auditor of said County to recommend such amount in the rates to be extended upon the tax roll of said County for said fiscal year on all property within said Improvement District No. 1 of the Sunnyslope County Water District.
