RESOLVED FURTHER, that said Board of Directors respectfully requests the Honorable Board of Supervisors of the County of San Benito, at the time when said Board fixes the taxes for County purposes, to include in the tax levy and collect a tax sufficient to raise said sum of \$_____ during the said fiscal year, such tax to be known as the "Sunnyslope County Water Disrict Bond and General Tax"; and further, said Board does hereby respectfully request the Auditor of said County to recommend such amount in the rates to be extended upon the tax roll of said County for said fiscal year on all property within said District.

RESOLVED FURTHER, that said Board of Directors respectfully requests the Honorable Board of Supervisors of the County of San Benito, at the time when said Board fixes the taxes for County purposes, to include in the tax levy and collect a tax, within Improvement District No. 1 of said District, sufficient to raise said sum of \$ ____ during the said fiscal year,

such tax to be known as the "Sunnyslope County Water District Improvement District No.1 Bond and General Tax"; and further, said Board does hereby respectfully request the Auditor of said County to recommend such amount in the rates to be extended upon the tax roll of said County for said fiscal year on all property within said Improvement District No. 1 of the Sunnyslope County Water District.
