A RESOLUTION MAKING DETERMINATIONS ON ENVIRONMENTAL IMPACT, APPROVING PLANS AND SPECIFICATIONS FOR THE INSTALLATION OF CERTAIN IMPROVEMENTS, CALLING FOR BIDS FOR WORK AND PROVIDING FOR NOTICE THEREOF

## GRAVEL ENVELOPE WELL NO. 7 PUMP AND PIPING

## SUNNYSLOPE COUNTY WATER DISTRICT

RESOLVED, by the Board of Directors of the Sunnyslope County Water District, San Benito County, California, that

- 1. The supplementation of existing District water supply facilities by the installation of a well pump and motor and piping for Well No. 7 in accordance with the plans and specifications, heretofore submitted to this Board is part of an ongoing project which was heretofore determined to qualify for a Negative Determination on December 6, 1984, pursuant to which a Negative Determination was filed with the County Clerk of San Benito County, is consistent with State and Local Guidelines adopted pursuant to the Environmental Quality Act and that the impact of the proposed pump and piping facilities will not be substantial, and that the Board does hereby find and determine that it qualifies for the negative declaration heretofore determined and filed under State Guidelines and under the Local Guidelines adopted by the District inasmuch as it will not have a substantial effect on the environment.
- 2. Those certain plans and specifications for the pump and for the Gravel Envelope Well No. 7, prepared by Dan Weatherly, District Engineer, and heretofore filed with the Secretary of said District, be, and the same are hereby, approved.
- 3. The publication of a notice inviting sealed proposals for the installation of the pump and piping for Gravel Envelope Well No. 7 for the Sunnyslope County Water District shall be made in the Hollister Evening Free Lance, a newspaper circulated in said District, there being no newspaper of general circulation printed and published in said District.

4. Sealed proposals for bids will be publicly opened, examined and declared on May 30, 1985, at the hour of 4:30 p.m. at the regular meeting place of the Board of Directors of the Sunnyslope County Water District, Bank of America, Hollister Office, Conference Room, 320 San Benito Street, Hollister, California, for the following:

The installation of a well pump and piping and the installation of all appurtenances thereto in accordance with the plans and specifications.

- 5. Payments for said work to be done by the contractor shall be made in cash by said District to the contractor on itemized estimates, duly certified and approved by the District Engineer and the Board of Directors, based on labor performed during the preceding month, but said District shall retain ten percent (10%) of the amount of each of such estimates and the accumulation of said amounts so retained will be paid to said contractor thirty-five (35) days after the completion and acceptance of said work by said District Engineer and the Board of Directors.
- 6. All proposals or bids shall be accompanied by a check payable to the order of said District, amounting to ten percent (10%) of the bid, or by a bond in said amount and payable to said District, signed by a corporate surety or by the bidder and two sureties who shall justify before any officer competent to administer an oath, in double said amount and over and above all statutory exemptions. Said check shall be forfeited or said bond shall become payable to said District, in case the bidder depositing the same does not, within ten (10) days after written notice that the contract has been awarded to him enter into a contract with the District, the faithful performance of which shall be secured by an undertaking in the amount of one hundred precent (100%) of the amount so bid, with sureties satisfactory to the Board of Directors, and which shall be accompanied by a labor and material bond in a sum equal to one hundred percent (100%) of the amount of said bid, under the provisions of Title 15 (commencing with Section 3082), Part 4, Division 3, of the Civil Code.
