RESOLUTION NO. 23

AUTHORIZING CONNECTION TO DISTRICT WATER MAIN

RESOLVED, by the Board of Directors, of the Sunnyslope County Water District, San Benito County, California, that

WHEREAS, GIOVANNI PATRIZI and FRANCES PATRIZI, hereinafter referred to as Grantors, have granted to this District a

Deed of Easement for water main purposes, a copy of which is hereto
attached, and by reference incorporated herein; and

WHEREAS, said District intends to construct, operate and maintain a water main in said easement in furtherance of the District's water transmission and distribution system; and

WHEREAS, no other compensation is to be paid for said easement;

NOW, THEREFORE, IT IS ORDERED as follows:

- 1. District shall, at its own expense, install one domestic service connection for the use of Grantors.
- 2. That said Grantors, any tenant of theirs, and their successors in interest, shall be, and they are hereby, granted the right to connect additional services to the water main, or mains, laid within said easement, upon payment of the regular District charges for making such connection, except that no charge shall be made for the connection granted in Section 1 hereof.
- 3. Any and all connections to be made to the District water main shall be made under the supervision of the manager of said District. The cost of making a physical connection to the water main shall be borne by the Grantors, tenants or successors in interest, making the connection.
- 4. Grantors shall have the right to use water from the District main, or from the fire hydrant installed thereon, subject

to the payment of the regular water rate established by the District and subject to the regulations governing any such connection.

Any water used outside the boundaries of the District is limited to the use of surplus water.
