RESOLUTION NO. 90-2

RESOLUTION OF THE SUNNYSLOPE COUNTY WATER DISTRICT
RE WATER SERVICE FOR EAST FAIRVIEW PROPERTY OWNERS

WHEREAS, the East Fairview Property Owners (Owners) have petitioned the County of San Benito for approval of a specific plan to develop residential housing on property located east of Fairview Road; and

WHEREAS, as part of the specific plan approval process, the County of San Benito has required that Owners provided satisfactory information regarding the service of water to the property if allowed to develop; and

WHEREAS, substantially all of Owners' property is within the Sunnyslope County Water District boundaries with the exception of three (3) parcels, which are within the sphere of influence and area on a waiting list to be annexed to the Sunnyslope County District boundaries; and

WHEREAS, Owners have petitioned the Sunnyslope County Water District Board requesting that we take a position regarding the service of water for the proposed project and advise the County of San Benito of same;

NOW, THEREFORE, be it resolved as follows:

1. It is the intent of the District to serve the properties located within the District boundaries for the East Fairview Specific Plan area on the same basis as it will serve any other property or project located within the District's service area, provided adequate supplies are available in terms of quality and quantity, and upon a first-come first-serve basis.

2. The Board cannot make a commitment to the County of San Benito that water service will be provided to Owners or to any other project located within the District Boundaries. Weather patterns will determine future water supplies. Further, hydrology studies are presently being conducted by a County Water Committee which will assist the District in determining water quantity and basin capacity.

3. In the event that water is available for service to Owners, Owners shall be required to follow standard procedural requirements for obtaining service from the District. Further, said water shall be served on a first-come first-served basis.

4. This resolution shall not represent a commitment of District to serve water. This resolution shall be submitted to the County of San Benito for its review as part of the Specific Plan approval process for the East Fairview Specific Plan.

THE FOREGOING RESOLUTION was adopted at a regular meeting of the Board of Directors of the Sunnyslope County Water District held on October 2, 1990, by the following vote:


