RESOLUTION NO. 284

A RESOLUTION APPROVING BUDGET AND FIXING TAX ALLOCATION FOR THE YEAR 1981-1982

RESOLVED, by the Board of Directors of the Sunnyslope County Water District, San Benito County, California, as follows:

- 1. That the balance on hand as of June 30, 1981, in each of the funds of the District shall be reserved for use by the District during the fiscal year 1981-1982.
- 2. That the budget, heretofore presented to this Board, be, and the same is hereby, approved and ordered filed with the Board of Supervisors, County Auditor and County Treasurer of San Benito County.
- 3. The minimum amount of money required by said District during the fiscal year ending June 30, 1982, for the purpose of paying the expenses of said District, including especially the amounts required for the payment of principal and interest on the bonded indebtednesses of said District, as it comes due, will be in the sum of \$17,022.50, consisting of \$5,610.00 for the General Obligation Bonds of the District of 1955 and \$11,412.50 for Improvement District No. 1 General Obligation Bonds of 1966; and it is hereby estimated that said sum is the minimum amount of money required by said District for such purpose during said ensuing fiscal year.
- 4. That the taxes to be levied for the purpose of raising moneys for said bond fund issue of 1955 shall be levied on all assessable property in said District during the said fiscal year, such tax to be known as the "Sunnyslope County Water District 1955 Bond Tax;" and further, said Board does hereby respectfully request the Auditor of said County to recommend such amount in the rates to be extended upon the tax roll of said County for said fiscal year on all property within said District.

- 5. That the taxes to be levied for the purpose of raising moneys for said bond fund issue of 1966 shall be levied on all assessable property in said Improvement District No. 1 during the fiscal year, such tax to be known as the "Sunnyslope County Water District Improvement District No. 1 1966 Bond Tax;" and further, said Board does hereby respectfully request the Auditor of said County to recommend such amount in the rates to be extended upon the tax roll of said County for said fiscal year on all property within said Improvement District.
- 6. That the Secretary shall forward certified copies of this resolution to the County Clerk, the County Auditor and the County Treasurer of the County of San Benito.
