

RESOLUTION NO. 127

A RESOLUTION PROVIDING FOR 1973
GENERAL DISTRICT ELECTION

SUNNYSLOPE COUNTY WATER DISTRICT

RESOLVED, by the Board of Directors of the Sunnyslope County Water District, County of San Benito, State of California, that

WHEREAS, pursuant to the Uniform District Election Law of the State of California (commencing with Section 23500, et seq. of the Elections Code) a General District Election will be held in said District on Tuesday, November 6, 1973, the same being the first Tuesday after the first Monday in November of an odd-numbered year, for the election of three (3) Directors to said District.

NOW, THEREFORE, IT IS HEREBY ORDERED, as follows:

1. That said General District Election shall be held, as provided by law, in said District on Tuesday, the 6th day of November, 1973.

2. That pursuant to Section 23511 of the Elections Code, the County Clerk of the County of San Benito is hereby requested to publish a Notice of Election once in the Evening Free Lance, a newspaper of general circulation published in said County. Such publication shall be had at least 75 days, and not more than 100 days, before the day fixed for the election.

3. That upon receipt of a copy of the published notice from the County Clerk, pursuant to Section 23521, the Secretary is directed to post said Notice in the District office.

4. Blank forms of "Official Filing Petition" for use at said Election shall be obtained from either the District Secretary's office or the office of the County Clerk, commencing on August 9, 1973, being the 89th day prior to the election.

5. Nomination petitions shall be filed with the County Clerk either by certified mail or during regular office hours but not later than Friday, August 31, 1973, at 5:00 o'clock P.M.

6. The establishment of election precincts, defining their boundaries, selection of polling places and appointment of the respective election officers will be determined by the County Clerk as provided by law.

7. The Secretary of this District is directed to forward a certified copy of this Resolution to the County Clerk, to be considered as a request that this District Election be conducted by the County, pursuant to Section 23523 of the Elections Code.

8. The County of San Benito shall be reimbursed all actual costs incurred by the County Clerk thereof in conducting the General District Election for this District, except the costs of publication of any statement of qualifications pursuant to Section 10012.5 and Section 23510.5.

9. Not later than Monday, November 26, 1973, at a regular or special meeting, this Board of Directors shall declare the elected candidates. The Secretary shall immediately make, sign, seal and deliver to each person elected and who shall have complied with Section 23559 of the Elections Code, a Certificate of Election.
